PERIOD OF CONSERVATION

RIGHTS OF THE CONCERNED

- 5. Pursuant to European Regulation 679/2016 (GDPR) and national legislation, the interested party may, in accordance with the procedures and within the limits established for by the current legislation, exercise the following rights:
 - Request confirmation of the existence of personal data concerning him (right of access);
 - Know their origin;
 - Receive intelligible communication;
 - Be informed about the logic, methods and purposes of the process;
 - Request the update, rectification, integration, deletion, transformation into anonymous form, blocking of data processed unlawfully, including data no longer necessary for the purposes for which they were collected;
 - In case of processing based on consent, receive their data provided to the holder, in a structured and readable form by a data processor and in a format commonly used by an electronic device;
 - The right to lodge a complaint with the supervisory authority.
